State of the Dockets: Current v. 3/31/2021

- Pending District Court Criminal + Infractions down 28.6%
- Pending DWIs down 28.9%
- Pending Felonies down 26.1%
- Pending Superior Court Civil cases up 5.3%
- Pending District Court Civil down 0.4%
- All cases down 26.2%



State of the Dockets: Current v. 1/31/2023

- Pending District Court Criminal + Infractions down 0.3%
- Pending DWIs down 14.5%
- Pending Felonies down 12.8%
- Pending Superior Court Civil cases up 4.9%
- Pending District Court Civil up 11.3%
- All cases down 1.3%




Technology Update

CRAVE Status


- All Courtrooms (218) have been surveyed
 - 2 Configurations per Courthouse
- 96 Counties have a CRAVE system available
 - 204 of 218 Courtrooms
 - 93.6% Completed
- 3 Counties (7 Courtrooms) scheduled
 - Carteret (2)
 - Week of June 17th
 - Cleveland (2)
 - Week of June 17th
 - Johnston (3)
 - Weeks of June 10th & 24th

Systems Deployed By Courtroom Type






May 2024 Usage

- Using the built-in analytics of the CRAVE Systems, 154 of the 204 CRAVE Courtrooms reported usage.
 - Those active Courtrooms reported 2,038 hours & 48 minutes of use.
 - 306-hour increase in total usage from April (1,732 hours)
 - Represents a 17.6% increase
 - 92.7 hours of total use per business day (22)
 - 27 minutes of usage per business day/device
 - 9 hours and 58 minutes of usage per active Courtroom
 - The remaining 50 deployed systems reported no activity.

CJ's Remote Proceedings Task Force

- Created in 2021 and co-chaired by Judge Marty McGee and NCSA VP Eddie Caldwell
- Deliverables
 - Remote Hearing Model Administrative Order
 - Motion/Objection and other model forms
 - Webex Scheduler to coordinate DAC inmate appearance times
 - Coordination with sheriffs' offices to provide connectivity within jails
 - Developed procedures with State Crime Lab for remote analyst testimony



Public Access Kiosks

- Earlier this month, AOC deployed 20 devices to Harnett, Johnston, Lee, Mecklenburg, and Wake counties.
- Kiosk users can:
 - Search court dates/events
 - File documents
 - Conduct Guide & File interviews
 - Make payments
 - Scan and print documents







Legislative Update

2023 Legislative Session Recap

Appropriations Act 2023

- 20% salary increase for district court judges over the biennium
- Four new district court judgeships in 2025
- Permits CDCJ to delegate jury excusals to the clerk with clerk's consent.
- Provides clerks with additional authority to redact PII from court documents.



2024 Legislative Session

2024 Legislative Requests

- Continued funding for BAPM implementation team
- Create seventh step to retain experienced magistrates
- Provide step increase for chief magistrates
- Expand magistrate qualifications to include LEO experience
- Fund Branch workload needs





Other Updates

Travel Reimbursements

- New financial management system implemented by OSC in October 2023 takes more time to enter reimbursement forms.
- AOC Actions:
 - Assigned additional staff to process travel forms
 - Revamped internal workflow to maximize efficiency and turnaround time
 - Streamlined auditing thresholds and processes
 - Engaged vendor to create web-based reimbursement form; piloting this summer
 - Working with OSC to develop batch upload process

Performance standard is to process every reimbursement form within thirty days of receipt.



Language Access

- Interpreter Resources
 - Eight staff interpreters throughout the state
 - ~75 contract interpreters
 - Telephonic interpreting
- Remote interpreting
- Recruitment efforts



JMARC Strategic Plan

- Official kickoff on March 6.
- Led by research team from UNCW with national drug court experience.
- Phase One (now September 1): Developing statewide strategic plan.
- Phase Two (October 1 February 1, 2024): Broader outcome and cost-benefit analysis.
