THE OLD WRONG MESSAGE

THE ABUSE OF CHILDREN

- Physical impact: childhood abuse leads to life long increased incidence of <u>medical disorders</u> separate from additional risk for <u>immune disorders</u>. (www.acestudy.org).
- Emotional impact: relationship difficulties, depression, PTSD, anxiety, substance use, *revictimization* and others.
- Spiritual impact: a wounding that sometimes hinders faith and belief with <u>resultant loss of faith and a sense of hopelessness.</u>

THE <u>RIGHT</u> MESSAGE THREAT ASSESSMENT	
A DIFFERENCE	
Child sexual abuse is the basis of victimization in sexual exploitation	
However, child sexual abuse (CSA) is very different in many ways Most victims do not disclose CSA in childhood, but if they chose to do so, it is for specific reasons.	
 CSA is a victim's secret and often a child gives an unconvincing disclosure with a high risk for recantation CSA in boys is often seen as a betrayal, not abuse 	
THE DIFFERENCE	
THE DIFFERENCE	
Child sexual exploitation is the insult to the injury of child sexual abuse In this form of maltreatment, victimization is often no longer a child's	
secret –as is the case in child abuse images, commercial sexual exploitation of children (CSEC), and online grooming Instead of one offender abusing several children, many times one	
victim has many abusers ~ "These perverts spread their victims around" (AK); "The seduction was slowwhen you're thirteen you just think these people are your friends" (JB);	

CSA versus	CSI

- We have decades of research regarding the many aspects of victimization of CSA.
- Internet and communication exploitation of children has grown to be an immense problem for the last 18 years and treatment professionals are far less knowledgeable in these cases.
- We don't know the long term victim impact, but increasing amounts of research reveal that there is worse victim impact in CSE cases.

ANOTHER DIFFERENCE

- In cyber-enticement, children are groomed into very sexualized beliefs that are beyond age appropriate normal psychosexual development.
- They become a compliant victim, "hooking up via computer" long before there is physical contact.
- Unlike in an offline scenario, they become convinced that this is a "rite of passage".

DIVERSE OFFENDERS NO SIMPLE PROFILE WHEN CHILD SEXUAL ABUSE IMAGES ARE PRESENT	
AVALANCHE TIMELINE • 1997-1999: Reedy had an adult pornography website business with multiple international webmasters; Landslide Productions was the portal to access (gaining 35% of the fees paid by subscribers) • 1999 − USPIS began to investigate evidence of CP and began the largest enterprise in the US causing 5 other investigations in the UK, Ireland, Switzerland, Canada, and Germany. • Reedy was convicted of trafficking in CP with eventual sentence of 180 years (↓1,335 years).	
NEWER USES OF CHILD ABUSE IMAGES • Sexually explicit material production is used as extortion and intimidation. • Child sexual abuse images are made to invoke guilt, self-blame and shame ~ causing not only nondisclosure of this type of abuse, but frank denial even when images are made known or shown to the victim ~ double silencing.	

Police Charge Teen In Facebook Sex Assaults Anthony Stancl allegedly tricked students into providing nude pictures.]

The same day Facebook claimed it was proud it had no legal cases involving registered sex offenders or members who met a minor on the <u>social networking</u> site, the Milwaukee <i>Journal Sentinel</i> reported police accused a teen of using the site to extort nude photos and blackmail students into performing sexual favors.	
The Waukesha County district attorney's office announced multiple charges against 18-year- old Anthony Stancl on Wednesday. Police and prosecutors accuse him of copying Facebook photos and using them to pretend he was a female so he could lure male students to send him nude photos. Once he had the photos, Stancl told the male students that the girl would release the pictures to the rest of the school if they did not perform sex acts on him, police	
So far, police believe Stancl obtained nude photos of 31 teen victims and they said that he coerced at least seven of the boys into sex acts in school bathrooms, a parking lot and in some	
victims' homes. The criminal complaint states that some of the boys were abused repeatedly. Stancl faces up to 293 years in jail if convicted on all counts, a judge said. Police said they discovered the scheme while investigating a bomb threat, which led them to	
Stancl and his computer. At the same time, one victim reported abuse after Stancl asked for nude pictures of the victim's brother, police said. Stancl's computer contained more than 300 photos and video clips of the local boys in 39 folders

WHY NOT TELL?


- •They appeared to "let it happen"
- They may have been smiling as they were directed to do
- Index children may have been coerced to recruit other victims (schools etc.) and were therefore "responsible bystanders" (e.g. Kindergarten series)
- Children were encouraged to be proactive in their own exploitation (masturbation) or with others (mutual)
- Children were shown their own images and threatened exposure to non-offending parents that they cooperated and did not stop the abuse

SEXUALLY EXPLICIT MATERIALS ON PLAY STATION 3 (14 MARCH 2009)

Anthony Scott O'Shea is one of the first offenders charged with promoting sexually explicit material, online solicitation of a minor and sexual performance of a child through a video game . The victim is an 11-year-old girl.

O'Shea met and spent several months establishing a relationship with the child in an videogame called Warhawk via PS3s online network.

The victim reported O'Shea when he kept asking for more pictures and wanted to meet her for a sexual encounter.

UNDERESTIMATED NUMBERS
Despite the fact that there are more than 120 million child sexual abuse images on the Internet, this remains an underestimated # of
 Girls who have reached nearly complete sexual maturation generally will not be included as sexually explicit material victims
 The average age of complete sexual maturation in girls is 14-15 years of age

ONGOING TRAUMA

- Sexually explicit material downloading is an infringement of a victim's privacy. Similar to the laws involving illegal music downloads as well as autopsy photo downloads, there is continued significant harm to the victim when images are downloaded.
- The resultant fear of discovery by others which is always present in victims is only increased when they know that images continue to be
- Outcome diagnoses of victims include PTSD, anxiety, depression and rational paranoia.

COMPLEX TRAUMA

- Mental health professionals in the US continue to define the victim impact when images are on the Internet.
- The concept of complex trauma seems to be a consideration in the area of abusive images, particularly when children are very young, have chronic abuse, may have been neglected, and especially if the abuse is sadistic in nature.
- \bullet These mental health problems really require qualified providers.

- A 19-year-old Southern California computer student is facing federal prison for hacking the webcams of Miss Teen USA Cassidy Wolf and a dozen other young women worldwide and trying to blackmail them by going public with naked photos he secretly took.
- Court records show the victims ranged from their late teens to early 20s, including some minors, and were located in Southern California, Maryland, Ireland, Canada, Russia and Moldova. The plot lasted from early 2012 until June 2013.
- Abrahams threatened to post the illegally obtained photos if his targets did not send him more nude images or strip for him on camera. At least two complied with his demands.

SEXTORTION

- The self-production of images in response to blackmail that previous images already exist and will be circulated if the victim does not comply with the blackmailer's demands.
- The end results are the production of abusive images (child pornography)
- This is a sexual crime with no "hands on contact"
- \bullet The long term victim impact is profound.

OUTING AND TRICKERY Ex-Rutgers student convicted of cyberbullying gay roommate starts jail term

The practice of publicly revealing personal information, usually pertaining to an individual's sexual orientation, without that person's consent.

	Frank Lombard, the school's associate director of the Center for Health Policy, was arrested		
	after an Internet sting, according to the FBI's Washington field office and the city's police department.		
	According to an affidavit by District of Columbia Police Det. Timothy Palchak, an unnamed informant facing charges in his own child sex case led authorities to Lombard.		
	Authorities said that Lombard tried to persuade a person, who he did not know was a police		
	officer, to travel to North Carolina to have sex with Lombard's child. The detective's affidavit charges Lombard identified himself online as "perv dad for fun," and		 _
	says that in an online chat with the detective, Lombard said he had sexually molested his son,		
	whom he adopted as an infant. The court papers say Lombard also invited the undercover detective to North Carolina to have		
	sex with the young boy, and even suggested which hotel he should use.		
	Lombard was charged in federal court in Washington with attempting to induce someone to cross state lines to engage in sex with a child. If convicted, he could face a maximum sentence		
	of 20 years in prison.

CSEC OF NATIVE AMERICAN CHILDREN	
• In the research monograph: <u>Garden of Truth: The</u>	
Prostitution and Trafficking of Native Women in Minnesota (Farley, Matthews, Deer, Lopez, Stark and Hudon, 2011) - evidence was found that 79% of adult trafficked women were victims of sex trafficking as children.	
• 53% of the adult victims survived sexual torture and 49% had been kidnapped.	
Children were often sold by their families to pay the rent, support drug habits or to get quick cash.

PROSTITUTION AND TRAFFICKING • This document provides a clear definition of the difference between prostitution and sex trafficking.	
Prostitution is the exchange of sex for money, drugs, influence etc. between two people.	
• Trafficking involves third party control (therefore a pimp or trafficker)	
 Exchange of sex acts for food, shelter and other needs, outcall/escort/cell phone; Internet advertised prostitution, massage parlors, pornography of children and
