258.30 ERECTING OR MAINTAINING SIGNS ON HIGHWAYS. MISDEMEANOR.

The defendant has been charged with [erecting] [maintaining] a [warning sign] [direction sign] [marker] [signal] [light] (or) [an imitation [warning sign] [direction sign] [marker] [signal] [light]] upon a highway.<sup>1</sup>

For you to find the defendant guilty of this offense, the State must prove two things beyond a reasonable doubt:

First, that the defendant [erected] [maintained] a [warning sign] [direction sign] [marker] [signal] [light] (or) [an imitation [warning sign] [direction sign]<sup>2</sup> [marker] [signal] [light]] upon a highway;

And Second, that the defendant was not authorized<sup>3</sup> to [erect] [maintain] such (imitation) [warning sign] [direction sign] [marker] [signal] [light]. If you find from the evidence beyond a reasonable doubt that on or about the alleged date the defendant, without authorization, [erected] [maintained] a [warning sign] [direction sign] [marker] [signal] [light] (or) [an imitation [warning sign] [direction sign] [marker] [signal] [light]] upon a highway, it would be your duty to return a verdict of guilty. If you do not so find or have a reasonable doubt as to one or more of these things, then it would be your duty to return a verdict of not guilty.
